CONSOLIDATED ELECTION APRIL 1, 2025 POLLS OPEN FROM 6:00 A.M. TO 7:00 P.M.

The Consolidated Election will be held on April 1, 2025 at all Monroe County, Illinois polling places listed on the last page of this election guide. The offices, candidates, and public questions published in this election guide will be printed on the official ballots in Monroe County. The voter's residence will determine which offices, candidates, and public questions appear on their official ballot.

Early voting begins on February 20, 2025 at the Monroe County Clerk's Office. The office is open Monday through Friday, 8:00 a.m. to 4:30 p.m. (except Holidays). Saturday early voting will be on March 29, 2025, 9:00 a.m. until noon.
